15 October 2021

On October 15, 2021, during a meeting of the President of the BeNeLux Chamber of Commerce Denis Van den Weghe with the Minister of Trade and Integration of the Republic of Kazakhstan B.Sultanov, the main directions of bilateral cooperation were discussed.

Denis Van den Weghe presented the main activities of the Chamber of Commerce and informed that the Board of Directors consists of representatives of such companies as Eurasian Resources Group, ArcelorMittal, NCOC, FoodVentures and Arendt & Medernach



The President of the Chamber drew attention to the total trade turnover of the BeNeLux countries with Kazakhstan, which from 2017 to 2019 amounted to **about 15.2 billion euro**.

Foreign direct investment from the BeNeLux countries since 2005 amounted to **more than 68.9 billion euro**.

Concluding the meeting, the parties agreed on to hold these meetings on an ongoing basis.

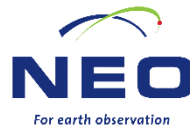
